**TERMS OF REFERENCE**  
**INDIVIDUAL CONSULTANT**  
**“Oracle Database Developer (Oracle-Developer)”**

**1. BACKGROUND**

The Punjab Safe Cities Authority (PSCA), established under Punjab Safe Cities Act 2016, ensures establishment, development and maintenance of an integrated Command, Control, and Communication system (PPIC3) for Police in major cities of the province for public safety. The Safe City is a concept for returning security and quality of life to today's complex cities through the use of technology, infrastructure, personnel and processes. In order to realize the vision of developing safe cities in the province, PPIC3 Centre has been developed for Punjab Police in the city of Lahore and other centers are being established in other larger cities of the province.

**2. OBJECTIVE/PURPOSE OF THE ASSIGNMENT**

The selected Individual Consultant will provide services for maintaining the existing Oracle databases, migrate existing databases and develop new databases according to requirements of different units. The consultant will have to work with stakeholders throughout the organization in order to identify opportunities and to drive business solutions, thereby bring optimization and improvement in police operational strategies.

**3. SCOPE OF SERVICE**

- Implementing the data model required by the application.
- Creating schema objects and implementing rules for data integrity.
- Prepare and document database design based on requirements by end user.
- Creating programming environment for a new development project.
- Writing server-side PL/SQL and Java subprograms and client-side procedural code that use SQL statements.
- Creating the application interface with the chosen development tool.
- Establishing a Globalization Support environment for developing globalized applications.

- Creating new applications.
- Updating existing applications.
- Maintaining existing applications.
- Instantiating applications in different databases for development, testing, education, and deployment in a production environment.
- Write ETL codes, update SQL statements and create shell scripts.
- Perform system design, upgrades, and maintenances according to business needs.
- Develop schemas, tables, triggers, indexes, sequences, constraints, functions and procedures.
- Understand business requirements and accordingly develop database models.
- Solve database usage issues and malfunctions.
- Experience and expertise in working with .Net Framework, JavaScript, HTML and Oracle.
- Monitoring database performance and tuning SQL queries and identifying and resolving scalability issues.
- Any other task assigned by the Higher Management.
