Note:

*If OEM is not participating itself and in order to avoid monopoly and to ensure fair, transparent and healthy competition, OEM shall issue more than one (multiple) Manufacturing Acceptance Letter (MAL) to Bidders / Applicants on its behalf to participate in the Pre-Qualification process. Further Manufacturing Acceptance Letter (MAL) shall be acceptable only from those offices of OEMs which are authorized for Pakistan region.

SECTION II: INSTRUCTIONS TO APPLICANTS

3.13.12 Joint Venture must comply with the following minimum qualification requirements: -

3.13.12.1 The lead partner shall meet not less than 40 percent of all qualifying criteria given in Section III Clause 30 heretofore.

3.13.12.2 Each of the partners shall meet not less than 25 percent of all the qualifying criteria given in Section III Clause 30.

3.13.12.3 The joint venture must collectively satisfy the criteria given in Section III Clause 30, for which purpose the relevant figures for each of the partners shall be added together to arrive at the JV's total capacity.
