**TERMS OF REFERENCE**  
**“HIRING OF LEGAL CONSULTANCY FIRM-**  
**SETTLEMENT AGREEMENT BETWEEN PUNJAB SAFE CITIES AUTHORITY**  
**(PSCA) AND M/S HUAWEI”**

**1. BACKGROUND**

PSCA is a statutory body established through the Punjab Safe Cities Authority Act, 2016 with the goal of monitoring and curtailing terrorism through construction, development, and maintenance of a city-wide integrated command, control, and communications system in the major cities of the Punjab. To conceptualize its flagship project, PSCA entered into a contract agreement with M/s Huawei Technologies Pakistan Private Limited (the principal contractor) on May 20, 2016 (the “Contract”), at a cost of USD 120 million (the “Project”). After certain variations and expansion to Kasur City, the cost rose to USD 139.4 million. Further, in December 2022, a settlement agreement was signed with M/s Huawei Technologies Pakistan Limited with the completion date for the closure February 29<sup>th</sup>, 2024.

**2. OBJECTIVE/PURPOSE OF THE ASSIGNMENT**

PSCA intends to hire a registered firm of legal consultants (the **Legal Consultant**), on the basis of its qualification and experience in accordance with Rule 46-A (*Selection process of firm of consultants*) i.e. “for short consultancy” of the Punjab Procurement Rules, 2014, (PPR-14). The primary objective of this consultancy is to draft a further settlement agreement, in consultation with PSCA, in respect of the PPIC3 Lahore Project.

**3. SCOPE OF SERVICE**

The Legal Consultancy Firm shall be required to provide the following consultancy services (the **Assignment**):

- i. Drafting of the settlement agreement (the “Settlement Agreement”), in light of PPIC3 Lahore main contract, variation orders, settlement agreement in consultation with and based on the information provided by PSCA.

**Exclusions**

- i. The consultant will not be required to assist PSCA in seeking any consents

- and approvals and / or attend any meetings with Huawei or third parties (including any government entities) pertaining to the Settlement Agreement.
- ii. The consultant will not provide any legal opinion on the compliance of the Contract, the previous settlement agreement, the Settlement Agreement or any other agreement in respect of the Project with any laws.

#### **4. CONDITIONS OF EVALUATION**

## **5. EXPECTED DELIVERABLES**

The consultant shall be responsible to deliver the draft Further Settlement Agreement b/w to PSCA within prescribed timelines.

## **6. TIME PERIOD**

The duration of the engagement of the Legal Consultant/Firm for the assignment shall be for a period of three (03) months as per the PPR-14.

## **7. PAYMENT SCHEDULE**

The Payment Schedule shall be finalized at the time of Contract execution with the Qualified/Successful Consultant within the limit prescribed in the Punjab Procurement Rules, 2014 (PPR-14).

## **8. PROCESS OF HIRING**

The firm shall be selected/hired on Least Cost Selection Method provided in Rule 45 (1) read with Rule 46-A of PPR-14 on the basis of applications/quotations submitted by the applicants. The process of this procurement shall be completed under the strict compliance of applicable relevant laws/ PPR-14.

## **9. Reporting and Coordination**

The consultant will report to Chief Operating Officer, PSCA / its representative and will coordinate closely with PSCA team.
