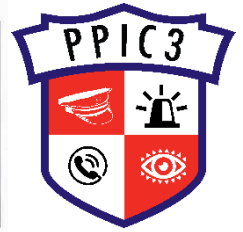

- iii. **A separate application must be submitted for the aforementioned categories of Projects/Schemes.**
- iv. **Deposit an application processing fee of Rs. 500 (Non-Refundable) for the post of Police Communication Officer through bank deposit slip at Bank of Punjab, Account Number: PK56BPUN6580045845500064, Titled: Chief Operating Officer Punjab**
- v. All the quotas shall be applicable according to Govt. policy.
- vi. The selected candidates will have to furnish surety bond to serve in the authority.
- vii. Government employee shall apply through proper channel.
- viii. Only eligible candidates will be called for the test, and those who pass the examination will be invited for an interview.
- ix. Applications carrying incomplete / incorrect information or received after due date shall be rejected.
- x. PSCA is an Equal Opportunity Employer. Women, minorities and persons with special needs are encouraged to apply.
- xi. Authority has the right to cancel recruitment process at any stage.
- xii. No. of vacancies can be increased or decreased at any time without any notice.
- xiii. A Police Verification Report from the Police Khidmat Markaz must be obtained before applying for the post.
- xiv. In the event of final selection, HEC-verified degree/transcript, and foreign degree equivalence certificate (if applicable) will be required.
- xv. Result awaiting candidates are not eligible to apply.
- xvi. Subsequent tests and interviews may be conducted by the Authority.
