

- iii. All the quotas shall be applicable according to Govt. policy.
- iv. Government employee shall apply through proper channel.
- v. Only eligible candidates will be called for the test, and those who pass the examination will be invited for an interview.
- vi. Applications carrying incomplete / incorrect information or received after due date shall be rejected.
- vii. PSCA is an Equal Opportunity Employer. Women, minorities and persons with special needs are encouraged to apply.
- viii. Authority has the right to cancel recruitment process at any stage.
- ix. No. of vacancies can be increased or decreased at any time without any notice.
- x. A Police Verification Report from the Police Khidmat Markaz must be obtained before applying for the post.
- xi. In the event of final selection, HEC-verified degree/transcript, and foreign degree equivalence certificate (if applicable) will be required.

While preferences for district postings will be obtained from the selected candidates, the final decision regarding assignments will rest solely with the Authority
