**TERMS OF REFERENCE  
“INDIVIDUAL CONSULTANT”  
(SUPERVISOR OPTICAL FIBER CABLE)**

**1. BACKGROUND**

The Project Management Office (PMO) is implementing multiple strategic initiatives, including the Islamabad Safe City Project, Safer Jails Project, and Faisalabad Industrial Estate Project. These projects aim to enhance security infrastructure, operational efficiency, and inter-agency coordination within the province. To ensure effective planning, execution, and monitoring of these initiatives, the services of an experienced Project Management Consultant are required.

**2. OBJECTIVE/PURPOSE OF THE ASSIGNMENT**

The selected individual consultant will provide services to Project Management office (PMO) team in consultancy Projects of Islamabad Safe City, Safer Jails and Faisalabad Industrial state.

**3. SCOPE OF SERVICE**

**1. Team Leadership & Management:**

- Lead, mentor, and supervise a team of OFC technicians and splicers.
- Schedule and assign daily tasks, work orders, and projects to team members.
- Conduct regular team meetings to communicate goals, safety briefings, and operational updates.
- Perform performance evaluations, identify training needs, and support team development.
- Foster a culture of safety, quality, and continuous improvement.

**2. Field Operations Oversight:**

- Plan and coordinate OFC installation, splicing, testing, and troubleshooting activities.
- Personally handle complex splicing tasks (Fusion, Mechanical) and OTDR/OLTS testing and analysis when necessary.
- Ensure all work complies with company standards, industry best practices, and client specifications.
- Review and approve Method Statements and Risk Assessments for field activities.
- Manage the team's inventory of tools, test equipment, vehicles, and materials.

**3. Quality Assurance & Documentation:**

- Perform quality checks on completed work, including splice closure installations, cable placements, and test results.
- Ensure accurate and timely completion of all documentation, including:
- Test results (OTDR traces, loss/attenuation reports)
- As-built drawings and network documentation updates

- Daily work reports, timesheets, and expense reports
- Splice logs and schematics

#### **4. Safety Compliance:**

- Enforce strict adherence to all health, safety, and environmental (HSE) policies and procedures.
- Conduct toolbox talks and ensure all team members use appropriate Personal Protective Equipment (PPE).
- Report and investigate any accidents, incidents, or near-misses.
- Ensure all worksites are set up with proper signage and traffic control measures.

#### **5. Client & Stakeholder Communication:**

- Serve as the primary point of contact for clients on-site for specific projects or issues.
- Provide regular progress updates to the Operations Manager and project management teams.
- Coordinate with other departments (e.g., NOC - Network Operations Center, planning, design) to ensure seamless operations.

#### **6. Emergency Response & Troubleshooting:**

- Lead the team's response to fiber faults and network outages, ensuring rapid restoration of services.
- Diagnose complex network issues and implement effective repair strategies.
