**TERMS OF REFERENCE**

**“INDIVIDUAL CONSULTANT**

**(OFC CONSULTANTS FOR O&M WORKS OF LAHORE)”**

**1. BACKGROUND**

The Punjab Safe Cities Authority (PSCA), established under Punjab Safe Cities Act 2016, ensures establishment, development and maintenance of an integrated Command, Control, and Communication system (PPIC3) for Police in major cities of the province for public safety. The Safe City is a concept for returning security and quality of life to today's complex cities through the use of technology, infrastructure, personnel and processes. In order to realize the vision of developing safe cities in the province, PPIC3 Centre has been developed for Punjab Police in the city of Lahore and other centers are being established in other larger cities of the province.

**2. OBJECTIVE/PURPOSE OF THE ASSIGNMENT**

The selected Individual Consultants will provide services as OFC consultants for O&M works of Lahore.

**3. SCOPE OF SERVICE**

- Plan and coordinate OFC installation, splicing, testing, and troubleshooting activities.
- Perform quality checks on completed work, including splice closure installations, cable placements, and test results.
- Splicing, testing of fiber optics cables, constructing splice cases, including but not limited to: Grounding, bonding, isolation.
- Must Familiar with all the fiber Cable testing.
- Manage OSP Activities.
- Performing work in accordance with industry standard.
- Performing routine route maintenance including recognizing and repairing route issue such as Hand Holes clean up.
- Familiar with the fiber Cable Standard.
- Reading Creating, and Maintaining Splicing Schematics and diagram.
- Preparing and maintaining splicing record.

- Follow up with contractor for the completion of task assigned by the customer and ensure the work is done.
- Conduct regular field inspection of buried and aerial fiber splicing lay out to ensure the work quality control and adherence to technical specification.
- Ability to multitask and work under pressure.
- Ability to pay close attention to detail and make good sound decisions based on information given.
- Survey of re-do works of damages by third party.
- Manage, perform and supervise cable splicing work for OFC links.
- Inspection of buried and aerial fiber splicing lay out Diagram and check fiber laying work according to Standard.

#### **4. PROFILE OF CONSULTANT**

The Consultant will be selected from the list of shortlisted consultants fulfilling the minimum requirement i.e. DAE and five years (minimum) experience in Fiber optic cable splicing and network design.

#### **5. NUMBER OF CONSULTANTS**

There will be Two (02) consultant.

#### **6. EXPECTED DELIVERABLES**

A monthly progress report on Consultant's work would be prepared and submitted, including tasks listed under "Scope of Services", above.

#### **7. TIME PERIOD**

The Consultant will be engaged for a period as decided by Competent Authority.
